PRELIMINARY

Description

BASICGUARD NB 3010 PMW is a transparent, one side heat sealable, non treated multilayer barrier film. It is specially designed as a web on thermoforming machines for the packaging of medical products to seal to suitable substrates to form an integral pack suitable for sterilization by ethylene oxide.

Heat sealable layer is modified to have a sealing capability to special coated papers without any fiber pick-up when the pack is opened.

This film may also be suitable for gamma sterilization. But some minor changes should be expected after sterilization. We advise to perform sterilization tests at actual conditions to approve. Please contact with our sales departments for more detailed information if required.
